The Faculty of Law and Management (FLM) is the largest Faculty of the University of Mauritius, despite remaining a relatively young Faculty, yet with a great potential. It aspires to consolidate and improve its status in the country and also to be recognized as one of the leading Faculty in the region. FLM offers a relatively large number of undergraduate programmes, around 8 post graduate courses as well as doctoral programmes in the broad area of Finance, Accounting, Business and Law. 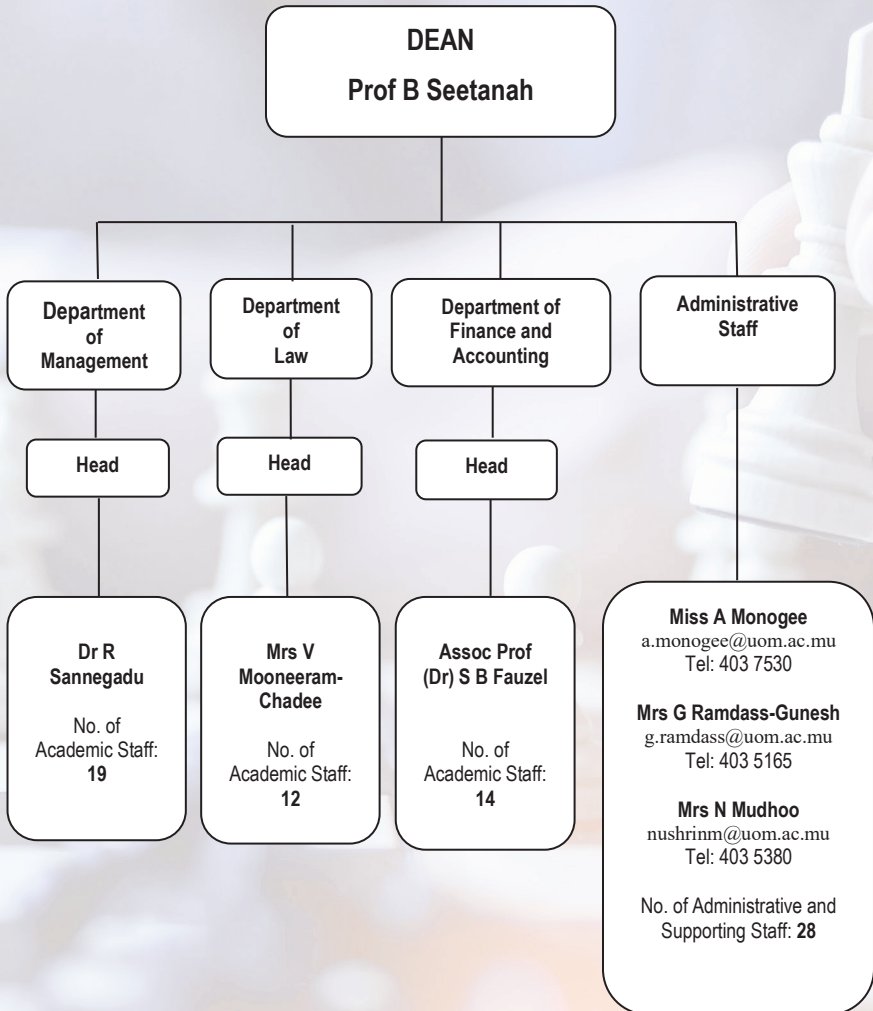
